Since 1990 until now I have been part of staffs that have grounded proposals for introducing the studying at the Faculty of Law, and not only, of the European Community law / European Union law with its branches and sub-branches, I have held undergraduate courses and contributed to the foundation of curricula for the establishment of postgraduate and Master courses in the field of European Community law/ EU law.

I was also part of the teaching staff who proposed the establishment, within the Faculty of Law of the University "Nicolae Titulescu", of the "Community Law" specialization, in accordance with the existing legislation in the field. Currently, this specialization is called *European and International Law* and is accredited (the only specialization accredited in Romania).
